("Pentair") by December 10, 2009 to be considered eligible for payment of a rebate.
- This report will be submitted to Pentair for review. The rebates will be issued once all information is verified. All installations are subject to random inspections by Pentair, Pacific Gas & Electric (PG&E), or an authorized third party.
- 5. This program is funded by PG&E. The customer is entitled to a \$100 rebate through this program. The customer is NOT eligible for any additional rebate through PG&E's Energy Efficient Pool Pump and Motor Rebate Program.**
