



**LETTER OF AGREEMENT (LOA)**

1. Installer agrees to abide by both the Procedure to Qualify for Program Rebates and Procedure to Claim Program Rebates, as outlined on the Procedures document. This document can be found on the program website.
2. The variable-speed pool pump must be installed per specification.
3. We request that the variable-speed pool pump initially be programmed to NOT operate between the hours of 12 p.m. (noon) and 6 p.m.
4. The customer must be verbally informed that participation in this program disqualifies them from participating in PG&E's Pool Pump and Motor Rebate Program. In addition, the invoice left with the customer **MUST** contain the following statement:

*"The customer is entitled to a \$100 rebate through this program. As Pacific Gas and Electric Company is funding this program, the customer is NOT eligible for an additional rebate through PG&E's Pool Pump and Motor Rebate Program."*

5. All installations are subject to randomly selected inspections by Pentair Water Pool and Spa, PG&E, or authorized third party.
